**SECTION 3 – Hazards Information****PRIMARY ROUTES OF ENTRY & EFFECTS OF OVEREXPOSURE:**

**EYES:** May cause chemical and mechanical irritation with symptoms including redness, swelling, pain, tearing, corneal abrasion, and blurred or hazy vision.

**SKIN:** Frequent or prolonged contact may cause irritation and possibly dermatitis. May aggravate existing skin conditions.

**INHALATION:** Inhalation of mist can cause irritation of nasal and respiratory passages.
