SECTION 3 – Hazards Information**PRIMARY ROUTES OF ENTRY & EFFECTS OF OVEREXPOSURE:**

EYES: May cause irritation with redness and pain disproportionate to level of irritation.

SKIN: Frequent or prolonged contact may cause irritation with localized redness and drying and flaking of skin. May aggravate existing skin conditions.

INHALATION: Inhalation of mist can cause irritation of nasal and respiratory passages. Abusive or excessive inhalation may cause irritation to the upper respiratory tract, dizziness, nausea, increased irregular heartbeat, and other central nervous system effects. Longer exposures to progressively higher levels may be immediately hazardous to life and can progress to unconsciousness and death.

SECTION 4 – First Aid Measures

STEPS TO BE TAKEN IN CASE OF SPILL OR LEAK: Allow propellant to evaporate. Maintain local exhaust and adequate ventilation. No smoking. Keep sparks, heat sources and open flame far away from spill or leak. Cover with absorbent material and sweep up. Wash area to prevent slipping.

Dispose of soaked absorbent material in accordance with Federal, State, and local laws.
