## 4. First Aid Measures

### EMERGENCY OVERVIEW

## 5. Fire-Fighting Measures

### SUITABLE FIRE EXTINGUISHING MEDIA:

Use water spray, fog, or foam.

### SPECIFIC HAZARDS ARISING FROM THE CHEMICAL:

Combustible liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion.

Runoff to sewer may create fire hazard.

### SPECIFIC FIRE-FIGHTING METHODS:
