4. First Aid Measures

EMERGENCY OVERVIEW

5. Fire-Fighting Measures

SUITABLE FIRE EXTINGUISHING MEDIA:

Use water spray, fog or foam.

SPECIFIC HAZARDS ARISING FROM THE CHEMICAL:

Flammable liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion.

Runoff to sewer may create fire hazard.

Prevent runoff from entering drains, sewers, streams or other bodies of water. Absorb spill with inert material. DO NOT use clay-type absorbent materials. Absorb unrecoverable product.
