### HAZARD STATEMENTS:

#### 4. First Aid Measures

##### EMERGENCY OVERVIEW

#### 5. Fire-Fighting Measures

##### SUITABLE FIRE EXTINGUISHING MEDIA:

Use water spray, fog, or foam.

##### SPECIFIC HAZARDS ARISING FROM THE CHEMICAL:

Flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion.

Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion.

Bursting aerosol containers may be propelled from a fire at high speed. Runoff to sewer may create fire or explosion hazard.

##### SPECIFIC FIRE-FIGHTING METHODS:

Prevent runoff from entering drains, sewers, streams, or other bodies of water. Absorb spill with inert material. Absorb unrecoverable product. Transfer contaminated absorbent, soil, and other materials to containers for disposal.
