When sprayed on surfaces, it works itself deep into the material to eradicate odors that have penetrated the surface. It is a ready-to-use spray that eliminates a broad spectrum of indoor odors, including those from smoking, body fluids, animals, food, garbage, mold, mildew, chemicals and paint. This product is acceptable for use in inedible product processing areas, non-processing areas and/or exterior areas of official establishments operating under the Federal Meat, Poultry, Shell Egg Grading and Egg Products Inspection Programs, provided that it is not used to mask odors resulting from insanitary conditions and that any characteristic odor or fragrance does not penetrate into an edible product area.
