4. First Aid Measures EMERGENCY OVERVIEW			

Get medical attention. **SKIN:** Wash with plenty of soap and water. If skin irritation or rash occurs, get medical attention. Take off contaminated clothing and wash it before reuse.

INHALATION:

Remove person to fresh air and keep comfortable for breathing. Call a poison center or a doctor if you feel unwell.

INGESTION:

Harmful or fatal if swallowed. Seek medical attention immediately.

SUITABLE FIRE EXTINGUISHING MEDIA:

Use water spray, fog or foam. SPECIFIC HAZARDS ARISING FROM THE CHEMICAL:

Flammable aerosol. In a fire or if heated, a pressure increase will occur, and the container may burst, with the risk of subsequent explosion.

6. Accidental Release Measures

PERSONAL PRECAUTIONS:

ENVIRONMENTAL PRECAUTIONS AND CLEAN-UP METHODS:

Stop all leaks. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Eliminate all ignition sources. Disperse vapors with water spray. Prevent runoff from entering drains, sewers, streams or other bodies of water. Absorb spill with inert material. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal.
