SECTION 3 – Hazards Information

EMERGENCY OVERVIEW: DANGER. Extremely flammable. Harmful or fatal if swallowed. Aspiration hazard. Vapor harmful. Can cause nervous system depression. Keep away from heat and flame. Contents under pressure. Do not puncture or incinerate container.

PRIMARY ROUTE OF ENTRY: Skin contact, inhalation
