

This air freshener contains an odor counteractant that eliminates odors and leaves the air smelling fresh, without CFCs or ozone-depleting substances, VOC COMPLIANT IN ALL STATES.

The dispenser activates the special metered valve at a predetermined interval, releasing a measured amount of air freshener which remains suspended in the air ensuring a fresh atmosphere. Each automatic release of air freshener renews the pleasant fragrance. Only one dispenser is needed for a room up to 30' x 20' x 10'.

This air freshener offers a wide spectrum of applications including, but not limited to: restrooms, convalescent homes, hospitals, clinics, doctors' and dentists' offices, hotels, motels, retail stores and kitchens.

DIRECTIONS FOR USE: Remove protective cap and install in an AirMatic Dispenser. Dispenser should be mounted 7 ft. from the floor and at least 8 ft. away from exposed foods. Position so that the concentrated spray will not hit people, animals, foods, drinks, feeds, food processing surfaces, or solvent-sensitive surfaces (such as polished or varnished materials). Use only in a well ventilated area. Avoid inhaling spray mist or vapor.
