## 4. First Aid Measures

### EMERGENCY OVERVIEW

- EYES:** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.
